- **Personal Financial Planning** A<sup>2</sup> will reimburse the employee for financial advising services for up to \$1,000 per year.

## TIME OFF

For employees with less than ten years' service, A<sup>2</sup> provides three weeks per year of PTO. For those greater than ten years' the benefit is four weeks. A<sup>2</sup> also provides at least 11 paid holidays as well as paid time off for jury duty and bereavement.

## **FLEX SCHEDULE**

A<sup>2</sup> has established a flexible work arrangement program for employees. This enables team members to vary the schedules they work during the designated two week pay periods when possible.
